Bridging the Gap to attract more people into the Commissioning Industry

What can we do?

BANYARDS.

The commissioning industry has historically struggled with recruitment difficulties and skills shortages which is an issue that needs addressing if we are to create a sustainable future for the commissioning profession. At Banyards we are looking at ways to increase both ours, and the attractiveness of the commissioning industry to allure new people into the commissioning world including recruits from schools, colleges, universities, and independent individuals entering our industry. Working with the Commissioning Specialist Association (CSA) this is an objective that needs to take focus in the year ahead.

The commissioning profession has many desired aspects for potential recruits that we, as leaders in our field, are looking to communicate. These include opportunities to gain a professional services qualification well respected in the wider construction industry, the opportunity to work in some of the most interesting and sometimes off-limits buildings across the UK, Europe and indeed worldwide and the chance to join an industry that is playing its part towards a better environment including Carbon Reduction and Net Zero. The commissioning industry offers a well-structured training programme and career path, using some of the latest technology to make buildings sustainable and Smart, to be creative and to produce tangible outcomes, to experience professional and friendly employers and to take part in interesting and practical work with flexibility.

We feel that much more can be done by us all to increase the visibility and awareness of commissioning. Example ways we can communicate include:

- Interesting and more accessible information via the CSA for potential recruits
- Use a range of channels including careers websites, careers advisers, teachers, and employers to promote the opportunities and benefits available in our industry
- · Offering more work experience opportunities
- · Increasing the use of internships and apprenticeships

Other examples for consideration include:

Raising the visibility of the CSA career pathway illustrated with real life examples and personal success stories; and helping individuals see the relevance of their skills and qualifications for commissioning and how they can fit in.

Value-based recruitment, drawing on the motivators of different groups and tailoring recruitment messages to align with individual business needs and values. Emphasising what new recruits could achieve within the first couple of years in their development and demonstrating the CSA pathways for different entry points.

A proactive education strategy with recruitment focused outcomes is needed, with our leading body the Commissioning Specialist Association at its forefront driving awareness, knowledge and working closely with our corporate members and employers.

What are Banyards doing?

We have picked up the baton to help bridge the recruitment gap with visits to career fairs in schools and colleges and have also worked with organisations such as The City of London and Career Ready which is a UK-wide charity linking employers with schools and colleges to open the world of work to young people aged 16-19.

We must not forget staff retention and have found a contributing factor to the longevity and positive outlook of our people starts at the very beginning of their employment involving induction, visible career pathways, personal development plans, training both technical and people management and an opportunity to work with supportive colleagues.

If individuals' expectations are met, they see and feel part of the plan; people stay and use their skills and qualifications to become a valued part of our business and progress within the industry.

We are continuing to develop our recruitment strategies with education drives, further internships, mentoring programs and employee funding, and working with the CSA we are taking a more active role in promoting our industry across all of the available recruitment channels.

BRIAN TOWNSEND LIFETIME CONTRIBUTION AWARD





The CSA Lifetime Contribution Award is one of the most prestigious industry honors that senior members of the commissioning world can be awarded.

This year we took a slightly different approach in awarding the Lifetime Contribution Award, and for the first time ever we awarded posthumously in honor of a late great grandfather to the commissioning world and without a doubt one of the main reasons I am the CSA Chairman today.

Brian Townsend first started in the commissioning industry in the 1970's working for Haden Young, he was a founder member of the CSA in 1990, CSA chairman between 1994 and 1996, as well as BESA president during the centenary year of what was then the HVCA Association

in 2004. While outside of work Brian was a judge at Crufts, and a valued member and chairman of the Cavalier Club Brian founded End Systems Limited in May of 1976 which has grown to be one of the leading commissioning companies in the UK, with training being always at the forefront of his mind, he was an advocate of the CSA training schemes ensuring all his engineers sat the relevant CSA exams, I still remember the days before the CSA distant learning courses were around, when he used to call us in the office to surprise us with a CSA exam, sure on one of these surprise tests I failed the Grade 3 exam with less than a 10 minutes to revise, but this was just part of his ways to keep us on our toes!

It's a testament to him that so many of the highflyers in the commissioning industry began their career with him and they still thrive to grow with the knowledge that he left them with. End Systems still continues to thrive and grow under the directorship of his daughter Kay, Brian was a champion of the industry, he truly made a significant contribution to all things commissioning and a true gentleman who will be sorely missed

On behalf of the CSA committees and members we send congratulations to the End Systems family on a much deserved award for Brian which is a further testament to his legacy.

Introduction to Commissioning Management 2-day Course

Congratulations to all the winners and finalists that attended the CSA awards form myself and keep up the good work.

A big thanks must be given to Jo and Kate in the CSA office for their sterling support throughout 2022, we have achieved lots of great progress for the Association, the commissioning management accreditation system is working extremely well with lots of commissioning managers submitting detailed dissertations and attending online interviews all of which would not be possible without the hard work from the CxM sub-committee (Paul Brown, Tony Anderson, Lee Hewitt, Rob Cleworth, Martin Elliott) so a special thanks from me that they have seen my vision for commissioning management come to fruition and finally every member of our committees and the sub-committees must also receive praise for their tireless work. Sincerely thanks to all.

I am very pleased to announce that Tony Anderson has taken over the role of CSA Vice Chairman, Tony will be working alongside myself for the next two years when he will take over as Chairman in 2024 which I'm looking forward to already! Tony has also dedicated hundreds of hours developing an Advanced Commissioning Management (ACM/G7) course, which is due to be released in 2024, this 2-day course will cover topics such as critical commissioning witnessing, CIBSE Code M updates, what makes a good CxM and will be delivered in a similar way to the ITCM. Also, a special mention to Gary James for stepping up as the CSA Training Chairman, Gary's passion for commissioning is already shining through in the committees in which we will see some great future training improvements.

A big thank you to Andy Watkin who stepped in as CSA Vice Chairman in 2021 who has been tremendous in helping me learn the Chairman's role and for his continuous contribution to the CSA.

One of my key actions for my tenure was for the CSA to be working more closely with other associations, to date we have re-developed CIBSE Code M Commissioning Management, we are currently working as a steering group on updating CIBSE Code A while also working alongside BSRIA to re-develop BG-49 and to produce a commissioning responsibilities matrix with BSRIA which will support the integrated critical commissioning work we undertake.

I'm sure most of us in the industry will have now had the email from BESA/SKILLcard regarding Commissioning Engineer cards obtained under employer's endorsements and that they will no longer accept renewal applications from 30th June 2024 unless they hold a nationally recognised construction related qualification, i.e. N/SVQs or approved equivalents. Please be assured that the CSA is working hard with BESA to rectify this issue, to date we have held numerous meetings with the BESA Policy manager, submitting all the CSA's training material as part of an application. In November we have a meeting set where we will present to the Construction Leadership Council (CLC) and Construction Skills Certification Scheme (CSCS) the CSA training systems in which we are aiming for our CSA Grades 1-6 & CM1 to 3, to be accepted as nationally recognised equivalents.

For now, that's all from me, hope the rest of 2022 goes well and look forward to 2023 and beyond for some exciting times in the Commissioning Specialist Association.

One major achievement in the year is our new commissioning management accreditation system, which sets out to demonstrate competency and experience while satisfying the criteria we have set out.

Pleased to announce that our collaborative work with CIBSE on developing Commissioning Management Code M has been a great success, working alongside key CSA companies and individuals in a steering group on this joint publication was a brilliant experience and testament to great collaboration between CIBSE and the CSA. The new code which is available now addresses commissioning processes taking into account accelerating technological advancement, increasing building complexity, tightening regulatory constraints, growing consumer demand for quality, surging environmental consciousness, and an urgent need to de-carbonise buildings.

Following on from the re-write of CIBSE Commissioning Management Code M we have taken this opportunity to tweak the introduction to commissioning management course (ITCM) this ensures we are delivering our training courses to the latest guides. Furthermore, our advanced commissioning management course (CM3/G7) which is being developed by Tony Anderson is near completion and will be released very soon. Each Sub-Committee Chairman went on to report progress and future key objectives of their individual Committee.
